WITNESSETH:

WHEREAS, by Ordinance 4386, dated January 9, 2012, the County accepted grant funds received from the Mid-America Regional Council Solid Waste Management District to be used to conduct a survey of citizens living in certain areas of Jackson County to gauge the interest and need for a yard waste facility to serve those areas; and,

WHEREAS, the County solicited proposals to perform these services under Request for Proposal 27-12, and by Resolution 17861, dated March 19, 2012, the County Legislature did award a contract to Institute for the purpose of conducting a yard waste survey in Jackson County; and,

WHEREAS, the Institute has the experience and expertise to perform such a survey; and,

WHEREAS, the Institute and the County have agreed to be bound by the provisions of this Agreement,

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Institute respectively agree with each other as follows:

- 1. <u>Consulting Services.</u> Institute shall fulfill its contractual obligations by performing a yard waste/recycling survey of certain citizen living in Jackson County, as set forth in the excerpt of Institute's response to RFP No. 27-12, attached hereto as Exhibit A and incorporated herein by reference.
- 2. <u>Payment</u>. The County shall pay Institute for its services rendered under this Agreement in an amount not to exceed \$15,000.00 upon receipt of Institute's invoice. Institute shall submit invoices for each project phase, as are listed on the cost proposal document attached as Exhibit B. The County shall pay such invoices in a timely manner.
- 3. <u>Expenses</u>. Institute shall pay all of its own expenses incurred in connection with its performance of this Agreement.
- 4. <u>Duration and Termination</u>. This Agreement shall be effective March 19, 2012, and continue through December 31, 2012, unless sooner terminated. The Institute or the County may terminate this Agreement by giving written notice to the other party, at least ten (10) days in advance of termination. The County shall be obligated to pay Institute for all services rendered by Institute under this Agreement up to and including the date of termination. Termination of this Agreement shall not constitute a waiver of the rights or obligations which County or Institute may be entitled to receive or be obligated to perform under this Agreement. Upon termination of this Agreement, the Institute will have no further obligations to the County under this Agreement.
 - 5. Independent Contractor. The Institute shall work as an independent

contractor and not as an employee of the County. Based upon its expertise and knowledge, Institute shall be subject to the direction of the County only as to the type of services to be rendered and not as to the means and methods for accomplishing the result. Institute shall report all earnings received hereunder as gross income and be responsible for its own Federal, State and Local withholding taxes and all other taxes, and operate its business independent of the business of the County, except as required by this Agreement, and may continue to conduct consulting work for other clients without prior consent of the County subject to the restriction on the receipt of County funds from more than one source.

- 6. <u>Assignment and Amendment</u>. Institute agrees, in addition to all other provisions herein, that Institute shall not assign any portion or the whole of this Agreement without the prior written consent of the County. The provisions of this Agreement may be amended only in writing signed by the parties.
- 7. <u>Time of the Essence</u>. Timely performance of all duties provided herein is of the essence of this Agreement.
- 8. Remedies for Breach. Institute and County agree to faithfully observe and perform all of the terms, provisions and requirements of this Agreement, and either party's failure to do so shall represent and constitute a breach of this Agreement, and in such event, the parties consent and agree that remedies for such breach shall include the following:
 - (a) The non-breaching party may immediately terminate this Agreement; and,
 - (b) The non-breaching party shall be entitled to pursue any legal remedy it

may have against the other party, and to collect all costs incurred including legal fees, as a result of said breach.

- 9. <u>Severability</u>. If any covenant or other provision of this Agreement is invalid, or incapable of being enforced by reason of any rule of law or public policy, all other conditions and provisions of this Agreement shall nevertheless remain in full force and effect and no covenant or provision shall be deemed dependent upon any other covenant or provision unless so expressed herein.
- 10. <u>Indemnification</u>. Institute shall indemnify, defend, and hold County harmless from any and all claims, liabilities, damages, and costs (including reasonable attorney's fees directly related thereto) arising out of the performance of the Services, if and to the extent caused by the negligence or misconduct of Institute.
- 11. <u>Conflict of Interest</u>. Institute warrants that no officer or employee of the County, whether elected or appointed, shall in any manner whatsoever be interested in or receive any benefit from the profits or emoluments of this Agreement.
- 12. <u>Incorporation</u>. This Agreement, together with RFP No. 27-12 and Institute's response thereto, incorporates the entire understanding and agreement of the parties.
