## 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, advised the Legislature that the data line that connects the downtown courthouse to the county offices in Independence was out for 2 days last week. The cable belongs to Southwestern Bell and they have resolved the problem by replacing a circuit card, which is now fully functioning. The MIS Department is waiting for a report on this incident from SWB and has also asked for a plan on how to prevent similar problems in the future. She will keep the Legislature informed as more information becomes available.

Katheryn Shields reported that the Full Employment Council recently became one of 22 organizations nationwide to receive a \$950,000.00 Rewarding Youth Achievement Grant from the United States Department of Labor. The goal is to increase the rates of both high school graduation and college enrollment by helping 450 juniors and seniors from 5 underprivileged area high schools. She said she worked for 6 years in the Concentrated Employment Program in the inner city and she knows how important this kind of opportunity can be for youth and their future. One of the initiatives of the Rewarding Youth Achievement Grant is to provide qualifying students with internships. Participation in the program is at no cost to the employer as a result of the grant. Ms. Shields has contacted county department heads to participate in this program in order to help the youth of Jackson County.

Katheryn Shields announced that the Department of Corrections will be hosting a breakfast on June 26, 2001 to benefit Harvester's. The breakfast will be held in the Jackson County Detention Center dining room from 7 a.m. - 10 a.m. The cost is \$5.00 per person or \$3.50 with the donation of a canned good. She encouraged everyone to attend the breakfast and to help Harvester's aid the less fortunate. She reminded everyone that this is the final week for the food drive for Harvester's.

Katheryn Shields congratulated the City of Independence for being named one of ten "All-America Cities" at a national competition held in Atlanta this week. The award was presented to Independence, Missouri in recognition of its youth programs, neighborhood revitalization efforts and assistance to the elderly. She recognized Independence for the outstanding work they have done in these areas.

Regarding sports in Jackson County, Katheryn Shields stated that the Administration and County Legislature have been working with the Royals and Chiefs for the last three years to figure out their needs and how to obtain funding for their needs. The Chiefs brought their ideas to the table this week and the Royals have agreed to complete their updated proposal by July 15, 2001. She said the idea of the downtown baseball stadium is perplexing but that she would remain focused on the Harry S Truman Sports Stadiums.

Victor E. Callahan, Chairman, felt that there was an absence of leadership from the Administration last week regarding Jackson County's intentions for the stadiums. He mentioned that the Administration did not support the Bonner/Rizzo legislation last year which included funding for the stadiums. He understands that Governor Holden has approved the plan submitted by St. Louis, Missouri and that Jackson County does not have a committment from the Governor.

Discussion regarding Harry S Truman Sports Stadiums.

Dennis Waits, County Legislator, said he is not in favor of the downtown baseball stadium. He requested the County Executive contact Victor Callahan, Chairman of the Legislature, when she receives the proposals from both teams so that Jackson County can come up with a united plan to present in Jefferson City.
