**TITLE:** Awarding a split contract for a Twenty-Four (24) Month Term and Supply Contract with One (1) Twelve Month Option to Extend for the furnishing of Heavy Equipment Rental Services for use by various County Departments to Roadbuilders Machinery & Supply Company, Inc of Kansas City, Kansas and H&E Equipment Services, Inc of Banton Rouge, Louisiana under the terms and conditions of Invitation to Bid No. 25-009.

**SUMMARY:** Various County Departments require a Term and Supply Contract for the furnishing of Heavy Equipment Rental Services. The Purchasing Department issued Invitation to Bid No. 25-009 in response to those requirements. A total of 569 notifications were distributed, twenty document takers viewed with two (2) responses received and evaluated. An Executive Summary of the Invitation to Bid, including the Contractor's Quotations and the using departments Recommendation Memos are attached. Pursuant to Section 1054.6 of the Jackson County Code, the Purchasing Department recommends a split award of a Twelve (12) Month Term and Supply Contract with One (1) Twelve Month Option to Extend for the furnishing of Heavy Equipment Rental Services for use by various

County Departments to Roadbuilders Machinery & Supply Company, Inc of Kansas City, Kansas and H&E Equipment Services, Inc of Banton Rouge, Louisiana under the terms and conditions of Invitation to Bid No. 25-009 as the best qualified bids received. A split award for Heavy Equipment Rental Services is recommended, which will ensure that any requesting department has multiple options in case one vendor does not have the equipment needed. Various Departments state an annual estimated usage of \$51,500. The award is made on an "as needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriations. Certificate of Compliance is on file.
