5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, mentioned the Kansas City firefighter Gerald K. "Mac" McGowan who died on the way to a call Sunday night after a pumper truck collided with two cars and hit a large tree. The veteran firefighter was 57 years old and a 32 year department veteran. Along with the Legislature, Katheryn sent sincere condolences to his family and fellow firefighters. Katheryn Shields said she was advised that his daughter in law is a Jackson County employee of the Records Department in Independence, Missouri. She said three other firefighters were injured in the wreck and wanted them to know that they are in our thoughts and prayers.

Katheryn Shields expressed condolences to Jackson County's Public Works Director, J.D. Stokes and his family as his father passed away unexpectedly this last weekend. James Dale Stokes of Kansas City, Missouri was 65 years old. She said thoughts and prayers are with J.D. and his family in this time of loss.

10 INTRODUCTION OF PROPOSED ORDINANCES AND ASSIGNMENT TO COMMITTEE

Robert A. Stringfield, County Legislator, said this legislation deals with whether the County Legislature wants to continue to allow the Administration to continue discretionary waivers in the future. He is asking for a yes or no vote. He said they had overwhelming public testimony from neighborhood associations, school board representatives. individual citizens against discretionary waivers, and the Kansas City Star had an editorial opposing waivers. The Attorney General said they were illegal. Mr. Stringfield said we have been told that we are the only county that allows these waivers. He said we allow the County Counselor to handle non-discretionary waivers. The tax waiver interest belongs to the entities that are on the levy; school districts, city governments, blind pension, libraries, etc. He said legislators should not be the judge as to what happens to their money, but as a body they should listen to their constituents. Overwhelmingly, they say no discretionary waivers of penalties and interest. He said the buck stops with the Legislature. He does not want to allow this Administration in the future to be able to give discretionary waivers. He said they need to stop playing games with the taxpayers. He said he revealed last week that there is a flaw in the system as far as rules. He asked that he be the sponsor of Ordinance #3535, then he noticed that there are two other sponsors. He said the rules have a flaw which allows a sponsor to withdraw. He has given his word that he will go forward with this and stated he is against discretionary tax waivers.

Dan Tarwater, County Legislator, said the County Executive is reviewing this and going through it very thoroughly and will come back to the legislature with a recommendation. This may be the recommendation, but that is the reason they withdrew the previous legislation and he will make a motion to do the same with this ordinance.

Bob Spence, County Legislator, said he does not believe anyone on the legislature is playing games with this issue. He said everyone understands it is an important issue and demands more study than Mr. Stringfield is willing to give it. He said he supports the motion to withdraw.

Ronald E. Finley, County Legislator, concurred with the motion to withdraw. He said they had a meeting with Ed Rucker, County Counselor and Mary Helen Murphy, Acting Director of Collections. Ms. Murphy is looking at a new policy on the discretionary waiver of penalties and interests. She has requested the opportunity, pursuant to previous discussion, to come back with a policy by mid-October. He feels this is reasonable since she is just taking over the department and no waivers are currently being granted. He said sometimes he gets insulted by expersions being cast on his intentions. He said this issue is much larger than they thought. They are trying to come up with a fair policy to deal with a question that has evolved over the years and to try to help people pay their taxes and remain in their homes. There is an ongoing situation with the Housing Information Center. There are about 60 citizens who are currently making payments under this program. Mr. Rucker and Mr. Finley have discussed this and would like to find a solution. He stated that all tax funds are being collected and have been collected for the last year.
