FIRST ADDENDUM TO THE MEDICAL SERVICES AGREEMENT Term and Supply Contract

THIS FIRST ADDENDUM made as of the <u>20</u> day of <u>April</u>, 2015, by and between JACKSON COUNTY, MISSOURI, (hereinafter referred to as "the County") and THE CURATORS OF THE UNIVERSITY OF MISSOURI ON BEHALF OF UNIVERSITY PHYSICIANS (hereinafter referred to as "University"), One Hospital Drive M263 MSB, Columbia, MO 65212.

WITNESSETH:

WHEREAS, the County has determined that it is in the best interest of its citizens to contract for the services of neuropathology consultation to assist the County's Office of the Medical Examiner with specialized brain examination and neuropathology services, as may from time to time be needed, at the direction of the Medical Examiner; and,

WHEREAS, the County and University did enter into a Medical Services

Agreement dated June 16, 2014, as authorized by Resolution 18544; and,

WHEREAS, the County and University desire to clarify certain compensation agreed to in the original Agreement;

NOW THEREFORE, the parties hereto do mutually agree as follows:

- Except as expressly provided herein, all provisions of the Medical Services Agreement between the parties dated June 16, 2014, shall remain in full force and effect.
- 2. The County shall pay University at the rate of \$500.00 per case.

(1) slide, \$100.00 for two (2) slides, and \$150.00 for three (3) slides to six (6) slides requiring special stains. Any additional slides beyond the first six shall have preapproval from the Chief Medical Examiner. Upon the Chief Medical Examiner's approval, additional slides shall be billed at \$50.00 each.

- This First Addendum to the Agreement shall be effective upon execution and extend through June 15, 2015.
- 4. This First Addendum, together with the Medical Services Agreement dated June 16, 2014, incorporates the entire agreement and understanding of the parties.
