Theresa Galvin, Chair, called the meeting of the Jackson County Legislature to order.

#### 1 ROLL CALL

#### 2 THE PLEDGE OF ALLEGIANCE

#### 3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Scott Burnett to approve the journal of the previous meeting held on October 07, 2019. The motion passed by a voice vote.

#### 4 HEARINGS

Theresa Galvin, Chair, asked Ronald E. Finley, County Legislator, to introduce Melissa Patterson-Hazley. Ms. Patterson-Hazley is the County's appointed representative on the Central City Economic Development Sales Tax District Board, which governs the implementation of a retail sales tax for the support of development and revitalization along the Prospect Avenue corridor. Ms. Patterson-Hazley was reappointed to the Board pursuant to Resolution #20288. See page 8 for details.

Jean Peters Baker, Prosecuting Attorney, presented information related to the audit of Jackson County COMBAT issued by BKD, LLP. Ms. Baker said that she previously stated she would order an audit of COMBAT in the event the administration was transferred to her department. She said she did not lobby to take over COMBAT, but she is open to any recommendations to improve COMBAT and make the program more transparent. She said that the report from BKD was completed without any

redactions and is available for review by the public on the COMBAT website.

Ms. Baker introduced Vince Ortega, Executive Director of COMBAT. Mr. Ortega said that BKD made 37 recommendations for improvement to COMBAT. These improvements centered on two primary categories: 1) COMBAT and other County departments and 2) COMBAT-funded agencies. The first category relating to COMBAT and other County departments covered the sales tax revenue projections and budgeting, COMBAT operations and procedures, COMBAT funding formula, other departments use of Anti-Crime Funds, employee salaries and benefits, and capital improvements and emergencies.

The second category relates to COMBAT-funded agencies and covered the areas of program monitoring and evaluation and expense reports.

BKD recommended that the COMBAT Administration add a Budget Coordinator position who would be responsible for all COMBAT budgeting and financial matters. This position would track all COMBAT funding and expenditures and would work closely with the Finance Department.

BKD also recommended that the COMBAT Administration have Community Engagement Program Monitors who would be responsible for site visits and ensuring that COMBAT funds are used for the appropriate intended purpose.

Mr. Ortega told the story of Tommy McGee, one of 13,684 people who benefitted from COMBAT funds, stating that these funds make a difference in the lives of people within our community.

Jean Peters Baker said that she hoped everyone would see this as an opportunity to turn the page on COMBAT. She wants to institute changes to make COMBAT programs better and to put the past in the past.

Ms. Baker said that there is another audit coming from the Missouri State Auditor, but she is hopeful that everyone can look forward and allow the COMBAT tax to do the work it does well – fighting violent crime and providing treatment programs for drug abuse. She said that they have instituted a series of listening sessions and have established a mechanism for reporting potential fraud and abuse. Ms. Baker said that the COMBAT agencies have been notified that their reports to COMBAT may change as a result of these new policies.

A copy of the Prosecuting Attorney's PowerPoint presentation is available in the Clerk of the County Legislature's Office.

Caleb Clifford, Chief of Staff, and Jaime Masters, Chief of Health Services, presented a report in response to the BKD audit.

Mr. Clifford presented information on crime statistics for Jackson County covering the last five years. He included information from the National Institute of Justice on its evaluation of the effectiveness of DARE programs.

Mr. Clifford said that all COMBAT funds spent were appropriated by the Legislature and were pursuant to a lawfully executed contract. There was no finding in the audit that any state or county law was violated. He said that his report highlights 10 errors that the administration believes are in the BKD report. He said that many officials were not interviewed as part of the audit, that the reported revenue in the report is not accurate, and that the funding percentages for County departments were set by Resolution #10950, which is a statement of intent only and not legally binding. Mr. Clifford presented a list of questions for BKD representatives such as areas of investigation they did not cover, certain people they were told to not contact, and what was in previous versions of the report.

A copy of the administration's response to the BKD audit is available in the Clerk of the County Legislature's Office.

The County Legislature went into recess at this time.

The County Legislature recovened.

#### 5 COMMUNICATIONS WITH AND REPORTS OF THE COUNTY EXECUTIVE

Frank White, Jr., County Executive, said that he agreed that it was time to move forward. He recommended that there be more communication between County officials. He said that when he became County Executive Jackson County was in a time of turmoil, but now is the time to work together on issue of infrastructure, salary study, and improvements at the Detention Center. He urged everyone to move forward in a positive manner and do the best for taxpayers.

Dan Tarwater III, County Legislator, asked for an update on the compensation study. Ed Stoll, Chief Administrative Officer, said that they should have a draft report from Evergreen within two weeks and a final report by November 1, 2019.

Theresa Galvin, Chair, said that she had requested that the reports be sent to the Clerk of the Legislature, but those reports have been routed through the Human Resources Department. She requested that reports be sent directly to the Clerk's Office.
