Distributors, Inc. under the terms and conditions of State of Missouri Contract No. CC250070(007), an existing, competitively bid government contract.

SUMMARY: The Jackson County Drug Task Force, Parks + Rec Park Rangers and Sheriff's Office all require a Term and Supply Contract for the furnishing of Law Enforcement Public Safety Gear. The Purpose of this contract is to streamline the procurement process for Law Enforcement agencies to purchase public safety equipment, apparel/outerwear, duty gear, tools, first responder/emergency medical gear, rescue gear, restraint gear, SWAT team gear and police vehicle equipment & accessories. The State of Missouri contract CC250070 is attached along with the using departments spend memos. Pursuant to Section 1030.4 of the Jackson County Code, the Director of Finance and Purchasing recommends the award of an Seven (7) month term and supply contract to end 10/31/2026 with the option to renew for two (2) additional one-year periods for the furnishing of Law Enforcement Public Safety Gear for use by various County departments to G.T. Distributors, Inc., under the terms and conditions of State of Missouri Contract No. CC250070(007), an existing, competitively bid government contract. This award is made on as "As Needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The annual estimated spend for use by various county departments is \$215,000.00. The recommended vendor has duly completed
