REQUEST SUMMARY	This ordinance appropriates \$500,000 in CARES Act funding to further address food insecurity in Jackson County brought on by the economic recession triggered by the COVID-19 pandemic. A total of \$1,800,000 will have been allocated for this purpose since the beginning of the pandemic. It further authorizes the County Executive to solicit applications for outside agencies to purchase and distribute food and other necessities to Jackson County residents in a maximum amount of \$30,000 per eligible agency. All recommendations for funding through the application process will be brought back before the County Legislature for final approval.
