WHEREAS, section 1606.1(3), <u>Jackson County Code</u>, 1984, authorizes the settlement of claims in excess of \$5,000.00 upon recommendation of the County Counselor, by Resolution of the Legislature; and,

WHEREAS, Auto-Owners Insurance Company has made a claim against the County seeking compensation for damage to a vehicle driven by insured Leland Fish allegedly caused by a County employee operating a road grader; and,

WHEREAS, after thorough investigation and negotiations, the County Counselor recommends a settlement in the total sum of \$10,975.00 to be paid by the County to Auto-Owners Insurance Company or its designee, in exchange for the full and complete release of all claims; and,

WHEREAS, the recommended settlement is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the

settlement of the claims of Auto-Owners Insurance, as recommended by the County Counselor, be and hereby is approved; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing be and hereby is authorized to issue a check in an amount totaling \$10,975.00 in full and complete settlement of this claim, payable to Trover Solutions, Inc., agent for Auto-Owners Insurance Company, pursuant to the specific direction of the County Counselor; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute an appropriate settlement agreement and any and all other documents necessary to give full legal effect to this Resolution.
