Achievements:

- Consolidated REO inventory of five local savings and loans in the New Orleans, Louisiana NHS program to facilitate homeownership in targeted areas.
- Trained NHS staff and board members at the national NRC conference on homeownership in Oakland, California.

- Managed the Homeownership Program, a pilot administered by the Neighborhood Reinvestment Corporation and funded privately by the Alton Jones Foundation.
- Worked to create new local partnerships that resulted in increased opportunities for low and moderate-income families to realize the dream of home ownership.

Achievements

- Instituted a purchase/rehab/resale program utilizing a line of credit from Missouri Housing Development Commission, private funds, tax incentives, and sweat equity, resulting in restoration of twelve vacant properties being successfully converted to owner occupied housing.
- Partnered with Mutual Benefit Life Insurance Company (now Assurant) to create their first "Model Block Program," designed to upgrade an entire neighborhood block of occupied properties, apartment complexes and one vacant property. The project utilized volunteer labor, our MHDC line of credit, city funds and a donation from MBI. This project was recognized by President Bush with a Presidential Private Initiative Award in 1985.
- Served as consultant for Mutual Benefit Life Insurance Company in training community groups on the model block concept.
