**RE: Bid Award Recommendation, Rock Island Greenwood Connector Trail Phase One (SW Jefferson to Hamblin Rd)**

The Parks + Rec Department priority is to extend the Rock Island Trail toward the City of Greenwood. Plans and specifications have been prepared for the Rock Island Greenwood Connector Project, and the Jackson County Purchasing Department issued an Invitation for Bid No. 25-034 and Federal Project Number STP 3301 (525) to meet those needs.

There was a total of seventy-four (74) Document Takers for the project, and four (4) responses were received. There were (2,030) invitations sent out. After reviewing the bid proposals, pursuant to Section 1054.6 of the Jackson County Code, the Purchasing Department and Parks + Rec recommend Terry Snelling Construction Independence, Missouri as the best bid received for all scopes of work.
