5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, said everyone was truly saddened by the news of John Friedmann's death Friday night. John was the Executive Director of the Jackson County Sports Complex Authority. All had hoped he would pull through. She, along with members of the County Legislature, shared their condolences with his family, friends and colleagues.

She said police still have few leads in the search for his assailant, and reminded anyone with information to call the TIPS Hotline at 474-TIPS (474-8477). There is a \$12,000.00 reward for information resulting in the arrest and conviction of the person(s) involved.

Everyone who knew John would say he was good man, who did a fine job. She reiterated that our thoughts and prayers are with his family in Minnesota during this time of loss. The wake is scheduled for Thursday evening in St. Paul, Minnesota and the funeral service will be on Friday. Members of the Sports Authority are discussing with the family the possibility of having a memorial service in Jackson County, Missouri since some people will not be able to travel to Minnesota.

Katheryn Shields said The Missouri Property Tax Credit or "Circuit Breaker" information that was mailed out has resulted in several hundred requests for applications. She said this level of success would not have been possible without this joint effort with H & R Block. She said she has received many thank you's from people and one note with this quote from Margaret Mead: "Never doubt that a small group of thoughtful, committed citizens can change the world. Indeed, it's the only thing that ever has."

Dan Tarwater, County Legislator, said he received calls from constituents who were very appreciative to receive the letter regarding the "circuit breaker" from Jackson County. He thought it was unfair that the newspaper and others called it a cheap advertising trick for H & R Block, which was totally untrue. He said if other tax services want to help in other areas Jackson County will be happy to work with them also.

Katheryn agreed. She said Jackson County entered into this partnership with H & R Block and they paid for mailing and provided free consultations to our citizens.

Henry Rizzo, County Legislator, said it was a great idea. But he agrees that we should make it available to everyone interested.

Katheryn said they are sending a response to all tax services that have written to complain to advise them that if they are willing to contribute, we will do a mailing with them. She said if any other services want to make that kind of financial and staffing commitment then Jackson County appreciates it and is willing to work with them.

Rhonda Shoemaker, County Legislator, asked if H & R Block is providing consultation for tax services.

Katheryn responded that H & R Block has agreed to provide free tax consultation to any Jackson County citizen on any of the tax relief measures outlined in the brochure that they mailed out, not just the circuit breaker. She looks forward to doing another mailing paid for by one or more tax services and with the same agreement that they would represent at no cost the citizens of Jackson County for advising them on those services and filling out the appropriate forms.

Ronald E. Finley, County Legislator, said the information is what is important. He also asked the Administration to ask H & R Block for the number of people they helped when this process is completed.

Katheryn Shields said she appreciated the support from the Legislature and was pleased with the positive response we have received from the taxpayers.

She wished Fred Arbanas a Happy Birthday.

Scott Burnett asked the Administration for an address for John Friedmann's family. Jay Haden, Acting County Counselor, said he would email the funeral home address to the legislators.
