**AN ORDINANCE** transferring and appropriating \$378,162.00 from the undesignated fund balance of the 2026 Park Fund and authorizing the County Executive to execute a contract with Tarkett Sports Construction-Central, LLC, of Lee's Summit, MO to cover construction and planning of pickleball courts at Fleming Park at a cost to the County not to exceed \$378,162.00.

**ORDINANCE NO. 6078**, April 13, 2026

WHEREAS, the Parks + Rec Department would like to construct four pickleball courts in Fleming Park; and,

WHEREAS, the amount of \$378,162.00 includes the construction costs of \$330,556.00, a 10% owners contingency of \$33,056.00, and the acceptance of Alternate #1 in the amount of \$12,850.00 for final grading and seeding and Alternate #2 in the amount of \$1,700.00 for a performance and payment bond; and,

WHEREAS, an appropriation and transfer are necessary to place the funds required to implement this Ordinance in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County MO, that the following transfers and appropriation be and hereby are made:

BE IT FURTHER ORDAINED that the Interim Director of Finance and Purchasing is authorized to make all payments, including final payment on the contracts, to the extent that appropriated funds are available for this purpose.
