#### 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, announced some fun things that will be happening in Jackson County for Halloween. Frontier Fright Night will be Saturday, October 24, 1998, from 7:00 to 9:00 p.m. at Fort Osage. Storytellers will be telling haunting tales from the frontier. Spirits from the Past will be on Friday, October 30, 1998, from 6:00 to 9:00 p.m. at Missouri Town 1855. The town will be lit only by luminaries and eerie glow of Jack-O-Lanterns. There will be storytelling and trick or treating. Finally, on October 31, 1998, at 8:00 a.m. there will be the Bust Your Pumpkin cross country run. This challenging 5K and 10K cross-country run will wind through scenic Fleming Park.

She also said that on the agenda today is legislation regarding the Domestic Terrorism Local Preparedness Program grant for \$250,000.00. Jackson County is the only jurisdiction in the metro area that had the opportunity to apply for this federal grant program. Funds will be used to equip fire departments and law enforcement agencies throughout Jackson County so they will be able to respond to acts of domestic terrorism. MARC will be assisting us in determining the actual needs and to distribute the money. This is another way that we are able to receive money and yet help the communities out east with potential problems.

Also, members of the Legislature should have received a notice of an emergency purchase. This is for replacing the ceiling in the Kansas City Legislative Assembly Room. The bid went to Mid-America Contractors, Inc. in the amount of \$46,000.00. Work is scheduled to begin this week and should be completed within 42 days.

Dennis Waits suggested that the acoustics be considered when the drop ceiling is removed. Katheryn Shields said they would make sure this is done.

Dan Tarwater suggested that the County combine some training with the HazMat units for the domestic terrorism teams.

The city of Kansas City went out for bid last year for energy savings in Municipal Auditorium, Bartle Hall and Kemper Arena. One company recommended \$8 million worth of changes and guaranteed the city would save through their utility bills the amount of money to pay off the \$8 million. Katheryn Shields said she has began talking with the City so that the same type of study can be done for the Jackson County Courthouse and City Hall. Perhaps we can get some proposals for updating some energy using sources.

Dixie Flynn asked when the new detention center will be opened and housing prisoners. Katheryn Shields could not give an exact date.
