ORDINANCE NO. 4624, June 2, 2014

WHEREAS, the trustees of the Elaine Feld-Stern Charitable Trust have made a \$1,500.00 donation to Jackson County COMBAT to support and promote efforts in the County to educate young people regarding the dangers of substance abuse; and,

WHEREAS, an appropriation is necessary in order to place the donated funds in the proper spending account; and,
