#### Project/Title:

Authorizing a Twelve (12) Month Term and Supply Contract with One (1) Twelve (12) Month Option to Extend, for the furnishing of International Dump Truck Repair for the Public Works Department to Rush Truck Centers of Kansas City, Missouri as a Sole Source Vendor.

### **Request Summary**

The Public Works Department needs a term and supply vendor to repair International Dump Trucks. The Public Works Road & Bridge Division has several International brand Dump Trucks that need repair. This equipment is necessary for daily operations throughout the year including the annual Road Program and Inclement weather snow season.

Pursuant to Section 1030.1 of the Jackson County Code, the Purchasing Department recommends Rush Truck Centers of Kansas City, Missouri for the repair of International Dump Trucks as a Sole Source.

Research done by both the Purchasing Department and the Public Works Division indicates that Rush Truck Centers is the closest International Truck repair shop capable of repairing this specialized equipment near the Kansas City area.

This award is made on an "as needed" basis and does not obligate Jackson County to pay any specific amount. The availability for funds for specific purchases is subject to annual appropriation.

It is estimated that the Public Works Department could expend approximately \$50,000.00 over the course of the year with Rush Truck Centers.

SUBJECT: Sole Source Vendor: Rush Truck Centers

The Public Works Department needs a vendor to repair International Dump Trucks. The Public Works Road & Bridge Division has several International brand Dump Trucks that need repair and this equipment is necessary for daily operations throughout the year including the annual Road Program and Inclement weather snow season.

The Purchasing Department bid such services and did not receive any bids for the specific repair of International Dump Trucks. While conducting research and calling several other vendors to see if anyone in the area could service such equipment, the conclusion was that International dump trucks requires proprietary diagnostic scanners and specialty trained mechanics to diagnose and perform work on these types of trucks. Rush Truck Centers is the closest International repair shop capable of repairing this specialized equipment within the Kansas City area.

For the reasons above, it has been requested that Rush Truck Centers be considered a sole source vendor.

It is estimated that the Public Works Department could expend approximately \$50,000.00 over the course of the year with Rush Truck Centers.
