WHEREAS, the American Rescue Plan Act (ARPA) of 2021, enacted by the U.S. Congress, provided financial support to local governments responding to the public health and economic impacts of the COVID-19 pandemic; and,

WHEREAS, Jackson County received a total allocation of \$136,551,645.00 in ARPA funds, with approximately \$70,447,641.00 remaining for distribution; and,

WHEREAS, ARPA funds must be obligated by December 31, 2024, and fully expended by December 31, 2026, with strict adherence to federal requirements for eligibility; and,

WHEREAS, the remaining \$70,447,641.00 will be allocated annually for 2024, 2025, and 2026 to reimburse Jackson County for eligible public safety, health, and personnel costs until funds are fully distributed; and,

WHEREAS, an appropriation is necessary to place the funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the undesignated fund balance of the 2024 ARPA Fund be and hereby is made:
