



The program will focus on positive involvement by young people. We will focus on performances that present an alternative to drug use, abuse and drug trafficking. We will target young people who have talent and provide programming which has a positive message. We hope to encourage young people to avoid jail time and negative behavior in the community. We hope to draw support from Combat Anti-Drug Funds. Budget for this program is \$15,000.00.


#### **Program 3 – Interfaith Service:**

This final program we plan to do collaboration between the health fund and the combat anti-drug program. We propose to bring together the young and the old and the people of all faiths. We will look at how we have addressed health, environment and violence in the past and how we plan to address these issues in the future. We will provide a forum to present various points of view and full participation from a wide sector of age groups and faith groups. We will draw \$5,000.00 from the Health Fund and \$5,000.00 from Combat Anti-Drug Program. The budget draw for this program will be \$10,000.00.
