I have reviewed the attached bids from the respective companies. After review, Reeves Weidman is the best supplier for this contract. I would anticipate the DOC will spent about \$25,000,00 to \$30,000,00 annually. They are a local company and we have a successful track record with them. Some parts and materials we order are not stocked by the vendor and must be ordered. In fact, some are not built until we actually order them. It is simpler to order locally than to go out of state and wait an additional time period for the parts. The discount offered by Reeves Weidman, is an across the board discount of 45% on all material and parts. This is a significant discount. The other vendor offers only a 20% discount and not on all items. It is my recommendation we use Reeves Weidman for the Department of Corrections plumbing supplies.
