

**PROJECT SAFE NEIGHBORHOOD
MEMORANDUM OF AGREEMENT**

AMENDMENT 2

This amendment to the original Memorandum of Agreement (MOA) dated on or about September 3, 2013 is entered into by and between the Kansas City Metropolitan Crime Commission (KCMCC) and the Jackson County Prosecutor (hereinafter referred to as JCP).

PURPOSE:

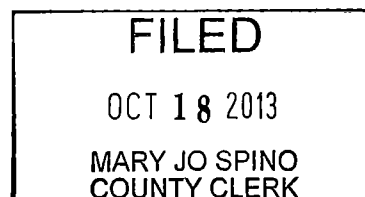
The KCMCC and the JCP agree to amend the original MOA for the purpose of extending grant period previously stated in the original as concluding in December, 2012 and amending the first amendment agreement signed June 6, 2012 by all parties. The original MOU stated that "Parties to the Agreement both agree that continuation of the agreement past the initial 24 month period will be contingent on the continued grant funding for PSN" and the first amendment read "\$40,000 in PSN funds will be available to extend this agreement to September 30, 2013." The availability of \$1,628.63 within the grant funding has been approved to be re-programmed for JCP making the total amount available \$41,628.63. These funds should provide reimbursement for the prosecutor assigned to the U.S. Attorney's office through the beginning of December, 2013.

AGREEMENT:

1. **Term:** The term of this Amendment to the original MOA shall be for an approximate 3 month period commencing September 30, 2013. Parties to this amendment both agree that continuation beyond the period shall be contingent on continued funding for PSN. Funding from BJA from the 2011 PSN Grant for JCP has now been set at a total of \$41,628.63, an increase of \$1,628.63 from the first amendment amount of \$40,000.00.
2. **Authority:** This MOA is established pursuant to the following provision(s).

Grant Number BJA FY 2011 PSN – Grant Award Number 2011-GP-BX-0080
3. **Services:** JCP, through the United States Attorney for the Western District of Missouri, agrees to provide the professional services of one prosecutor attorney as set forth in the original contract:
 - a. One prosecutor assigned to the U.S. Attorney's Office for the Western District of Missouri.

All other provisions of the Amendment-Services section shall remain the same as those established in the original MOA and/or its amendments.



4. **Relationship:** Remains as established in the original MOA and/or its amendments.
5. **Payment:** Process remains as established in the original MOA and/or its amendments. \$41,628.63 is available to expend and invoicing may occur on a monthly or quarterly basis. Final invoice must be received in December, 2013 as closeout of this federal grant must be done by December 31, 2013.
6. **Compliance and Program Audit:** Remains as established in the original MOA.
7. **Office Space and Secretarial Support:** Remains as established in the original MOA.
8. **Termination:** Remains as established in the original MOA.
9. **Notice:** Remains as established in the original MOA.
10. **Miscellaneous Provisions:** Remains as established in the original MOA.
