#### 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, said County Legislators will be receiving invitations to the State of the County address scheduled to be held on Wednesday, February 23, 2000 at noon in the Kansas City Legislative Assembly Area. The purpose of the speech is to talk about what we have accomplished and where we will be going.

She announced that Jackson County is the first county in Missouri to offer the Missouri Saving for Tuition program (MOST). Employees are being offered this benefit through payroll deduction. MOST is a program developed by State Treasurer, Bob Holden, to invest in your children's education and not pay state income tax on it as long as the money remains in the fund. It is not limited to just Missouri schools. Bob Holden will attend a meeting on Friday, February 4, 2000 at 10:00 a.m. in the Kansas City Legislative Assembly Area to do a kickoff and inform employees of this project.

Katheryn Shields announced that registration has begun for Spring Softball leagues. Sunday and Friday nights are still available for league play at the Frank White and 140th and Holmes complexes. The first game is scheduled to be held March 29, 2000.

Terry Young, County Legislator, asked about customer service in the Collections and Assessment departments. She has been receiving calls and there was also an article in the Kansas City Star.

Katheryn Shields said she would be happy to give a report to the Legislature next week. Jackson County has installed a new phone system to make it more user friendly. She will have staff from both departments available to answer questions and hear suggestions.

Dan Tarwater, County Legislator, asked if the Collections department is on-line so customers can e-mail messages concerning their tax bills.

Katheryn Shields said we are not on-line yet, but this issue will be addressed in the report next week.

Ronald E. Finley, County Legislator, reminded the County Executive that in the last budget the Legislature did approve funding of on-line services. He asked purchasing to give a schedule of these upgrades. He has done some reading on another project developed by the State Treasurer called the Link Deposit Program. This program is to encourage local banks to become involved in a number of activities to benefit the community. He asked the Administration to check and make sure that the banks used by Jackson County are a part of this program.

Katheryn Shields said she will look into this and try to have a report by next week.

Ronald E. Finley asked if Katheryn Shields will speak for 90 minutes in her State of the County address.

Katheryn responded it would be more like 15 minutes.
