

**IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI**

**AN ORDINANCE** transferring \$129,537.00 within the 2023 Anti-Crime Sales Tax Fund, appropriating \$277,378.00 from the undesignated fund balance of the 2023 Anti-Crime Sales Tax Fund, and authorizing an extension to the Victims of Crime Act Grant for use by the Prosecuting Attorney's Office's Victim Services Program.

**ORDINANCE NO. 5808**, October 23, 2023

**INTRODUCED BY** Venessa Huskey, County Legislator

WHEREAS, the Prosecuting Attorney's Office has been awarded a Victim's of Crime Act (VOCA) grant in the amount of \$277,378.00 by the Missouri Department of Social Services office's Victim Services Program, for the period of October 1, 2023, through September 30, 2024; and,

WHEREAS, the grant will cover partial funding for the salaries of six victim advocates; and,

WHEREAS, this grant requires local matching funds in the amount of \$129,537.00 to cover the unfunded portions of the program; and,

WHEREAS, an appropriation and transfer are necessary in order to place the grant and matching funds in the proper spending accounts; now therefore,

**BE IT ORDAINED** by the County Legislature of Jackson County, Missouri, that the following transfer and appropriation be and hereby are made:
