

**ADDENDUM TO  
COOPERATIVE AGREEMENT  
COMBAT Substance Use Disorder Treatment  
(March 1, 2020, through December 30, 2020)**

AN ADDENDUM TO THE AGREEMENT by and between Jackson County, Missouri, hereinafter referred to as "County", and **SHEFFIELD PLACE, 6604 EAST 12<sup>TH</sup> STREET KANSAS CITY, MO 64126**, (a Missouri not-for-profit corporation), hereinafter referred to as "Organization."

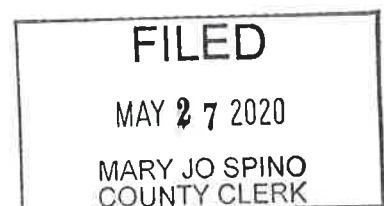
WHEREAS, by Resolution 20365, dated February 3, 2020, the Jackson County Legislature authorized a Cooperative Agreement with Organization (the "Prior Agreement") to provide substance use disorder treatment services to certain eligible persons; and,

WHEREAS, by Ordinance 5329, dated April 27, 2020, the County Legislature authorized additional funding for Organization to assist it in providing these services in view of unanticipated expenses that will necessarily be incurred by Organization due to the current and ongoing Coronavirus/COVID-19 pandemic; and,

WHEREAS, this addendum provides a suitable mechanism by which this additional funding can be made available to Organization;

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and Organization respectively promise, covenant and agree with each other as follows.

1. **Prior Agreement to Remain in Effect.** Except as specifically provided herein, the Prior Agreement between the parties shall remain in full force and effect pursuant to its terms.
2. **Additional Compensation.** The total amount payable to Organization shall be increased in the amount of **\$5,000.00**, to a new total of \$85,000.00. This amount shall be payable upon receipt of Organization's monthly invoice(s) and supporting materials documenting expenditures incurred pursuant to the supplemental budget attached hereto as Exhibit A.
3. **Term.** The term of this Addendum shall commence as of March 1, 2020, and shall continue, together with the Prior Agreement, until December 30, 2020, unless sooner terminated pursuant to paragraph 6, 19, or 26 of the Prior Agreement. All expenses must be incurred during this time period in order to be eligible for reimbursement under this Addendum.



4. **Incorporation.** This Addendum, together with the Prior Agreement, contains the entire understanding and agreement of the parties, and modifications hereto shall be enforceable only if in writing, signed by the parties hereto.
