# 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Mike Sanders, County Executive, explained that Resolution #17392 will replace Ordinance #4255 which is to freeze funds so they can be used for raises for Jackson County employees in 2011. This process is necessary in this volatile economy. It is an unusual step to assure that the money will be available. He said the County Legislature agrees that raises are a budgetary priority in 2011.

Theresa Garza Ruiz, County Legislator, asked if the 3% will be a Cost of Living Adjustment (COLA) for all employees.

Mike Sanders said he thinks merit raises make more sense. He said he does not recommend a COLA but if the Legislature wants it they can look at that option.

Theresa Garza Ruiz confirmed that this is a raise for employees and not elected officials. Mike Sanders said she was correct.
