A RESOLUTION declaring a certain John Deere tractor and rotary cutter owned by the Parks + Rec Department as surplus and unusable property.

RESOLUTION NO. 21828, December 16, 2024

INTRODUCED BY Charlie Franklin, County Legislator

WHEREAS, the Parks + Rec department was in possession of a John Deere tractor and rotary cutter that were stolen on or around September 14, 2024; and,

WHEREAS, an insurance claim was submitted regarding the theft and a check for \$50,000.00 was received, these funds are to be included in the 2025 budget request; and,

WHEREAS, the Director of Finance and Purchasing recommends that said property be declared surplus and unusable pursuant to Chapter 11 of the Jackson County Code; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the property within the various County departments further described and itemized in the attached declaration forms, be and hereby is declared surplus, as indicated and as provided for in Chapter 11, Jackson County Code, 1984; and,

BE IT FURTHER RESOLVED that the Director be and hereby is authorized to execute any and all documents necessary to give effect to the intent of this Resolution.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.

Narrative

On September 17th 2024 at 0800 hours I was dispatched to Landahl Maintenance area in report of a tractor and Flex Mower being stolen from the maintenance area.

I arrived on scene at approximately 0831 hours and met with maintenance workers Kat Bauer, Dan Farmer, and Frank Fisher, to gather information of the incident.

Mr. Farmer informed me that he and Mr. Fisher arrived to the area at approximately 0750 hours and noticed that the tractor, a John Deere 7200, and a John Deere Flex Mower were missing from the area. Mr. Farmer immediately called Kat Bauer to inform her of the situation and she afterwards called and informed the rangers. Mr. Farmer stated that the tractor and the flex mower were both in the area on September 13th and both must have been stolen over the weekend.

After gathering this information I then sent an email to Monica Litchi requesting more information about both pieces of equipment. I left the area at 0908 hours.

A local farmer named Rick R. Wooderson sent me an email on 09/18/24 stating that he had friends living in the area that had seen the tractor leaving the area at approximately 1800 hours on 09/14/2024.

Monica Litchi had sent me an email with more information on both pieces of equipment stolen, the paperwork for the equipment has been attached to the report. Ms. Litchi had also stated that a John Deere tractor equivalent today for replacement would cost approximately \$89,000, and the Flex Mower replacement would cost approximately \$25,500.
