

**SECOND ADDENDUM TO
COOPERATIVE AGREEMENT**

THIS SECOND ADDENDUM made this 1 day of October, 2012, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called "County" and **UNITED INNER CITY SERVICES**, 2008 East 12th Street, Kansas City, MO, 64127 hereinafter called "UICS."

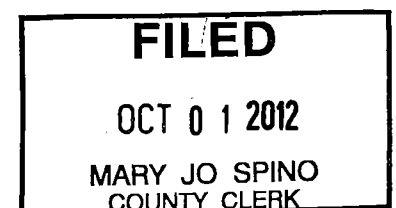
WITNESSETH:

WHEREAS, UICS and County entered into a Cooperative Agreement dated December 21, 2011, whereunder UICS agreed to provide art education, youth services, and child development programs for 2012, as authorized by Resolution 17754, dated December 6, 2011, at a cost to the County not to exceed \$50,000.00; and,

WHEREAS, pursuant to the First Addendum, dated February 23, 2012, and authorized by Ordinance 4392, dated February 13, 2012, the funding allocation authorized by the original agreement was increased by \$222,901.00; and,

WHEREAS, it is necessary to revise the original budget presented by UICS by reallocating \$10,000.00 from the supplies budget line to the personal services budget designation, to provide for an additional teacher's assistant to support children enrolled in the program in need of intensive behavioral support in the classroom, as is more fully described in the attached Exhibit A and incorporated herein by reference; and,

WHEREAS, the execution of this addendum is authorized by Resolution 17986, dated September 24, 2012;




NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and UICS respectively agree with each other as follows:


1. Except as expressly provided herein, all provisions of the Cooperative Agreement between UICS and County, dated December 21, 2012, and the First Addendum dated February 23, 2012, shall remain in full force and effect.
2. The Cooperative Agreement of December 21, 2012, is amended by the substitution of Exhibit A attached hereto, for the Exhibit A attached to the Cooperative Agreement.
3. This Second Addendum to the Agreement, together with the Cooperative Agreement, dated December 21, 2011, and the First Addendum dated February 23, 2012, shall be effective January 1, 2012 and shall extend until December 31, 2012.
4. This Second Addendum to Agreement, together with the Cooperative Agreement dated December 21, 2011, and the First Addendum dated February 23, 2012, incorporates the entire understanding and agreement of the parties.

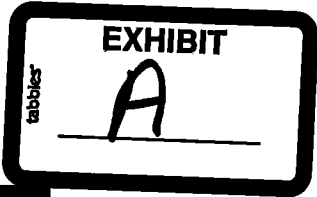
