Amending the Contracts Resulting from RFP 17-19 with JCDC, LLC Dated December 23rd, 2019 and September 02, 2020 to Execute a Change Order That Would Allow Redistribution of Existing Project Funds Between Existing Project Components.

Request Summary
<p>It is the request of the Public Works Department that Change Order No. 1 be executed between the County and JCDC, LLC. The purpose of the change order is to allow redistribution of funds from existing project components where savings have been realized to account for additional project needs.</p> <p>Due to the pandemic and the improvement of digital assembly, much of the allocated component reimbursable funds were not utilized. It is the intent of this change order to accommodate a number of pre-design services and project related expenses not accounted for within the Owner's Representative's budget. These services include Special Regulatory Permitting, Real Estate Communication Support, Appraisal Services and Site Survey. Unspent reimbursable funds previously approved and authorized from Components 1.0, 2.0, 2.1, 3.0, 4.1, and 4.2 will be transferred within Component 4.1 Service Fee. No additional funds are required as part of this request.</p>
