A RESOLUTION authorizing the Legislative Chairman to execute the County's agreements with political subdivisions and nonprofit agencies for the expenditure of 2024 Jackson County American Rescue Plan Act (ARPA) funds, at a cost to the County not to exceed \$25,979,385.00.

RESOLUTION NO. 21784, October 30, 2024

INTRODUCED BY DaRon McGee, Sean E. Smith, Manuel Abarca IV, Donna Peyton, and Venessa Huskey, County Legislators

WHEREAS, the American Rescue Plan Act (ARPA) of 2021, enacted by the U.S. Congress, provided for payments to local governments navigating the impact of the COVID-19 outbreak; and,

WHEREAS, in 2023, 118 program applications were submitted and 60 were approved for funding. These applications were reviewed and vetted by independent analysis and deemed compliant with ARPA funding guidelines:
