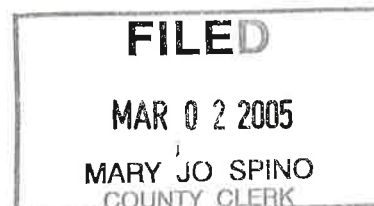
**RE: APPOINTMENT TO COMMISSION ON HUMAN RELATIONS

Family

- I was born July 3, 1947, and have been a life long resident of Jackson County Missouri.

Employment History

- I was employed by Smith St John Company immediately after graduation from college. I was an Estimation Engineer for Smith St John Company from 1970 to 1972. I received the "New Comer of the Year" award for outstanding performance in engineering from the Missouri Restaurant Association in 1971.
- I joined the Upjohn Pharmaceutical Company in December, 1972. I was hired to help begin a new Consumer Products division.
