5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Marsha Murphy, County Executive, said that last Monday the County agreed to move forward with a proposal for an annex to the detention center. The next day Judge Whipple told the County to go for it.

Today there will be a resolution drafted by the Administration and the Chairman of the Legislature to establish an implementation committee. The committee will function as the oversight committee to draft plans for building additional space for housing a minimum of 300 inmates. The plan is to be provided to Judge Whipple within 90 days. Charles Megerman, Director of Corrections and Gary Dannaldson, Purchasing Director, will continue to search and negotiate for additional space to bring jail population down to 624 as required by the Judge.

The County has surveyed all municipalities within the State of Missouri and found only 50 additional jail spaces are available. The County did locate a halfway house that can house up to 40 weekend inmates.

There will be four additional resolutions/ordinances introduced for the following:

- 1. Contracts for placement of inmates in outside facilities
- 2. Health care costs to increase Truman Medical Center staff at the jail and increase funding for dental care
- 3. Cots will be purchased to keep the population down.
- 4. Staffing and transportation costs to transport inmates to other facilities
