All pricing shall remain fixed and in effect for each of the contracted years to include all possible renewal periods unless prevailing market conditions warrant an adjustment as defined in the bid document.

Termination of this contract may occur in the event funds from local, state or federal sources are not obtained and continued at an aggregate level sufficient to allow for the purchase of the indicated quality of goods/service, in which case the obligations of each party hereunder shall thereupon be terminated immediately upon receipt of written notice.

The Circuit Court Purchasing Agent, or designee, shall be the sole judge as to the fact of the fulfillment of this agreement and upon any breach hereof said Purchasing Agent or designee shall, at their option, declare this agreement void, and for any loss or damage by reason of such breach, whether this agreement is annulled or not, A. Arnold Moving shall be liable.

A. Arnold Moving shall indemnify the Circuit Court against any and all claims for injury to or death of any persons; for loss or damage to any property; and for infringement of any copyright or patent to the extent caused by A. Arnold Moving or A. Arnold's employee or sub-supplier.

The Circuit Court shall not be precluded from receiving the benefits of any insurance A. Arnold Moving may carry which provides for indemnification for any loss or damage to property in A. Arnold custody and control, where such loss or destruction is to County property. A. Arnold Moving shall do nothing to prejudice the Circuit Courts' right to recover against third parties for any loss, destruction or damage to County property.
