ADDENDUM TO AGREEMENT

THIS ADDENDUM TO AGREEMENT, by and between JACKSON COUNTY, MISSOURI, hereinafter referred to as "the County," and the CITY OF KANSAS CITY, MO Board of Police Commissioners, 1125 Locust, Kansas City, MO, 64106, a state agency of the State of Missouri organized under Section 84.3450 et seq. of the Revised Statutes of Missouri, hereinafter referred to as "Board," is made and entered into this 24 day of February , 2011.

WITNESSETH:

WHEREAS, by Resolution 17241, dated April 12, 2010, the County and the Board did enter into an agreement whereby the Board agreed to provide drug prevention services through the 2010 Drug Abuse Resistance Education (DARE) programs, at a cost to the County of \$239,418.00; and,

WHEREAS, the Jackson County Drug Commission has authorized the release of additional funds and modification to the agreement for the 2010 D.A.R.E. program and has established an additional allocation for the Board for 2010, in the amount of \$11,905.00; and,

WHEREAS, by Resolution 17409, dated November 8, 2010, the County Legislature has authorized the County Executive to enter into this Addendum to Agreement;

NOW THEREFORE, in consideration of the mutual covenants and promises herein contained, County and the Board do hereby additionally agree as follow:

1. Except as hereinafter specifically modified, all of the terms of the prior



Agreement between the parties dated October 11, 2010, shall remain in full force and effect and the terms and conditions thereof are incorporated herein by reference.

- This Addendum to Agreement shall be effective as of November 8, 2010 and 3. shall extend, with the original Agreement, through December 31, 2010, except that expenditure may be made with the proceeds of this addendum through March 31, 2011.
- 4. This Addendum, together with the Agreement dated October 11, 2010, incorporates the entire understanding and agreement of the parties.
