

EXTENSION TO
LABORATORY SERVICES AGREEMENT
Term & Supply Contract

This **EXTENSION TO LABORATORY SERVICES AGREEMENT** ("Extension") is entered into and effective as of the 1st day of July, 2018, by and between **THE CHILDREN'S MERCY HOSPITAL**, a Missouri Nonprofit Corporation, ("Hospital") and **JACKSON COUNTY, MISSOURI**, a Constitutional Home Rule Charter County of the State of Missouri, ("County"), for the use and benefit of the Jackson County Medical Examiner's Office, ("Medical Examiner's Office"), and its execution has been authorized by Resolution No.19909 as a Term and Supply Agreement awarded pursuant to the terms and conditions of Request for Proposals No. 67-14.

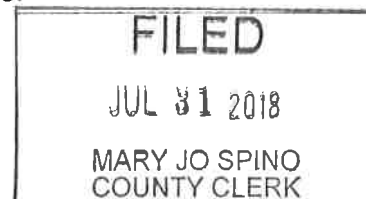
WHEREAS, pursuant to County Resolution 18775, the parties entered into a Laboratory Services Agreement effective July 1, 2015 ("the Agreement"), whereunder the Hospital contracted to provide certain laboratory services to the Medical Examiner's Office; and

WHEREAS, the Agreement would have expired on June 30, 2018 unless extended by the parties pursuant to Section 1 of the Agreement; and

WHEREAS, the parties are desirous of extending the Agreement through August 31, 2018;

NOW THEREFORE, in consideration of the mutual covenants and agreements of the parties hereto, it is understood and agreed as follows:

1. **Agreement to Remain in Effect.** Except as specifically provided herein, the Agreement shall remain in full force and effect pursuant to its terms.



2. **Term.** The term of this Extension shall commence as of July 1, 2018, and shall continue through August 31, 2018, unless earlier terminated as provided in the Agreement.

3. **Entire Agreement.** This Extension, together with the Agreement, contains the entire agreement of the parties and supersedes all prior or existing agreements, written or oral, between the parties dealing with the subject matter hereof. This Extension may be changed only by an agreement in writing, signed by all the parties hereto. Time is of the essence hereof.
