BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be authorized to accept the donation of three (3) buses declared surplus

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to execute any and all documents necessary to give effect to the intent of this Resolution.
