5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, reported there has been some concern about outside agencies and what was required of them and what was not. An educational packet is being put together and should be ready in the next couple of weeks. The County Counselor is working with MIS to come up with the visual aides.

She said meetings with the different departments will be set up to talk to the employees about what we did in this budget and what we hope to do with merit raises in the coming year. She invited the Legislature to participate and a schedule will be sent to them when it is ready.

Katheryn Shields has asked each department to put together a plan of what they will be doing with merit raises over the next year based on what they have done in the past. She has also asked Finance, based on past experience, what we might be able to expect in terms of merit raises. She would like to come before the Legislature next month with a plan that will say what we expect to have in terms of money available, and what we expect to do with it.

She said that the 1999 budget books are here and will be distributed at the end of the meeting.

Katheryn Shields announced that the Jackson County Industrial Development Authority is hosting a reception to show appreciation to those who assist in promoting economic health and vitality in our community. It will be held on Tuesday, February 9, 1999 from 5:00 to 8:00 p.m. in The Grand Ballroom at the Adam's Mark Hotel.

Ronald E. Finley, County Legislator, asked if the County Executive had time to consider an amendment to the Executive Order that has been in place regarding financial reporting. Some of the agencies have indicated to him that the order had not been enforced in the past and they are having difficulty. Katheryn responded that she is looking into the problem and hopes by next Monday to issue an amended Executive Order.

Ronald E. Finley asked if the matter could be discussed at the next Finance and Audit Committee meeting. Katheryn Shields responded that it would be fine and she would bring the amendment to him next week.
