5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, said they have fallen behind on awarding employee of the month awards, so she wanted to take the time to present them.

First she awarded the Employee of the Year award for 2005 to Amy Coffer with the Parks Department, who just returned to work from maternity leave. She said Amy was nominated by Dianne Kimzey for being such an integral part of the development and implementation of the Rec-Trac program for the Parks Department. From the beginning Amy provided exceptional internal customer service to each division to make sure the program was implemented efficiently. In order to do this, Amy had to educate herself on each Division's operations, to make sure the program fit the Division's needs. For all her hard work and dedication to Jackson County and the Parks Department, Katheryn presented her with the award.

The January 2006 Employee of the Month award was presented to a team of 16 employees from the Parks Department. This team designed and built the beautiful Christmas in the Park displays for the 2005 event, which was the 18th season. In addition, this year they did an exhibit for Channel 4 for their Love Fund, at the corner of 31st Street and Southwest Trafficway, which was an exhibit that was seen day and night. The team was nominated by Michele Newman. Michele said it takes this dedicated staff, their creativity, passion, heart and pride to make this magical event happen. She said Christmas in the Park is the largest event with regards to attendance and man hours that Jackson County offers to its citizenry. Over 200,000 people enjoy this event every year.
