

**SECOND ADDENDUM TO  
LEGAL SERVICES AGREEMENT**

**THIS SECOND ADDENDUM** made this 9<sup>th</sup> day of June, 2017, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called "County" and **WILLIAMS & CAMPO, P.C.**, 400 SW Longview Boulevard, #210, Lee's Summit, MO 64081, hereinafter called "Legal Counsel".

**WITNESSETH:**

WHEREAS, Legal Counsel and County entered into an Agreement dated February 10, 2016, whereunder Legal Counsel agreed to perform legal services, advice, and assistance to the Jackson County Drug Task Force (JCDF), as authorized by the County Legislature through its Resolution 19065, dated January 25, 2016, at a cost to the County not to exceed \$2,000.00; and,

WHEREAS, by Resolution 19320, dated November 28, 2016, the Legislature did authorize an increase to this contract; and,

WHEREAS, by Ordinance 4977, dated May 1, 2017, the Legislature did authorize an additional increase to the Agreement with Legal Counsel for the furnishing of an updated governing agreement between the JCDF and its member agencies;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Legal Counsel respectively agree with each other as follows:

1. Except as expressly provided herein, all provisions of the Legal Services Agreement between Legal Counsel and County, dated February 10, 2016, and the First Addendum dated December 19, 2016, shall remain in full force and effect.



2. The maximum sum to be paid by County to Legal Counsel shall be increased by the amount of \$1,300.00 for 2017; such sum to be utilized by Legal Counsel for its services in updated the JCDF's governing agreement.

3. This Agreement shall begin January 1, 2016, and continue through December 31, 2019.

4. This Second Addendum to Agreement, together with the Agreement dated February 10, 2016, and the First Addendum dated December 19, 2016, incorporates the entire understanding and agreement of the parties.
