## 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, announced that the Liggett Road Bridge will be opening at around 5:00 p.m. on Tuesday. This date meets our October 31, 2000 deadline. The old bridge, built in 1955, had a 15 ton load limit, a lot of deterioration and a sharp curve on the east end. The opening of this bridge is a major improvement for the citizens driving on this road.

The first actual traffic light owned and operated by Jackson County is being installed. This is a first in Jackson County history and will be located at the intersection of Liggett Road and Woods Chapel.

Halloween at the County will be on Tuesday, October 31, 2000. This event is being coordinated with the City of Kansas City, Missouri and activities have been planned at both locations. Halloween will also be celebrated at our other facilities. There will be a number of contests and hopefully every department will win in some category. Also, the kids from Operation Breakthrough will be coming to the Kansas City Court House to help us celebrate.

Katheryn Shields said she has been talking to Mayor Kay Barnes about the upcoming election. She also has calls in to Mayors' Stewart and Marinovich. By all accounts the election next Tuesday, November 7, 2000 is going to be close. As government workers we should all take seriously our responsibility to vote. A "GO VOTE" rally will be held at noon next Monday, November 6, 2000, the day before the election. This rally is not to tell people how to vote. It is a rally to encourage employees of both Jackson County and the City of Kansas City to go vote on Tuesday, November 7, 2000. Voting is not just a right but also a responsibility and everyone is urged to attend.

Victor E. Callahan, Chairman, asked the administration if the budget would be ready for the legislature by November 15, 2000.

Katheryn Shields said that the budget will be ready on that date.
