WHEREAS, by Ordinance 3790, dated July 17, 2006, the Legislature did accept a grant awarded to the Family Court Division by the Office of State Courts Administrator for juvenile detention alternatives initiative programs; and,

WHEREAS, the purpose of the Juvenile Detention Alternative Initiative project is to establish and support detention reform in accordance with juvenile detention alternative initiatives; and,

WHEREAS, the Office of State Courts Administrator has awarded a supplementary grant to the Family Court Division in the amount of \$15,000.00 and has extended the grant period through October 31, 2008; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the unappropriated surplus of the 2008 Grant Fund be and hereby is made:




