**TITLE:** Awarding a thirty-four (34) month term and supply contract to end 3/25/2028 with the option for up to three (3) additional one-year extensions for the furnishings of Uniforms with Related Products and Services for use by various County Departments to UniFirst (Clean Uniform), under the terms and conditions of Sourcewell Contract No. 011124-UFC, an existing, competitively bid government contract. UniFirst (Clean Uniform) under this contract provides uniforms and work apparel through purchase and rental programs. They also provide various facility service products, such as floor mats, mops, wiping towels, and restroom products. This will combine two contracts that the County has with this vendor, the Uniform Rental Services and the Mat Rental Services contracts.

**SUMMARY:** Various County Departments require a Term and Supply Contract for the furnishing of Uniforms with Related Products and Services. Sourcewell contract No. 011125-UFC gives access to the following types of products & services: Professional on-site analysis, more than 35,000 in-stock products, measurement and fitting at your location(s), specified number of garments for each individual, professional laundering and finishing, regular uniform and product deliveries, inspection of all work clothing for rips and flaws, automatic garment repairs, auto replacement of worn and damaged garments, inventory control with itemization, quick outfitting of new employees. The 011124-UFC UniFirst (Clean Uniform) Contract, 011124-UFC UniFirst (Clean Uniform) Benefits Page, and Using Departments Spend Memos are attached. Sourcewell is a local government unit and service cooperative that facilitates a competitive public solicitation and contract award process for the benefit of government, education, and nonprofit agencies. Cooperative purchasing provides participating entities and suppliers increased administrative efficiencies and the power of combined purchasing volume that result in overall cost savings. Pursuant to Section 1030.4 of the Jackson County Code, the Director of Finance

and Purchasing recommends the award of a thirty-four (34) month term and supply contract to end 3/25/2028 with the option to renew for three (3) additional one-year periods for the furnishing of Uniforms with Related Products and Services for use by various County Departments to UniFirst (Clean Uniform), under the terms and conditions of Sourcewell Contract No. 011124-UFC, an existing, competitively bid government contract. This award is made on as "As Needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The annual estimated spend for use by various county departments is \$45,000.00 The Jackson County Compliance portal was checked and the recommended vendor had a Status of "Certificate Issued and Emailed to Vendor".
