5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, said there was a public hearing held last week hosted by the Public Works Department. The hearing was regarding an update for the Public Works Master Plan. There were 25-30 people in attendance, not including county staff and consultants. The public saw presentations on proposed changes to Jackson County's Master Plan including land use, stormwater and erosion issues. She thinks it was a positive event and she thanked Rhonda Shoemaker for attending. The County intends to sponsor these kinds of public hearings on various subjects more often in the coming year, primarily focusing on County road projects. Legislators will receive invitations in advance. Katheryn said she is scheduled to make a stormwater presentation on Monday evening to the Independence City Council on the Jackson County Stormwater Management Plan. She said the Jackson County Stormwater Commission has been meeting and has completed the first phase, Study of the Watersheds. She said the County is now building partnerships with the other cities, the development community, state and federal agencies as well as citizens who may be experiencing flooding problems to look at this issue on county-wide and then a water shed basis. She believes this will create much better planning for the County and put us in a position to access state and federal funds that may be available. She said there is an ordinance on the agenda today that deals with stormwater regulations. She thanked the Legislature for their support.

Henry C. Rizzo, County Legislator, asked for an update on the stadium issue.

Katheryn Shields said they are trying to regroup and talk to all the interested parties. She said the Sports Authority is taking the lead and will hopefully come back to the Legislature with recommendations. She said both teams want to stay at the stadium.

Henry C. Rizzo asked if there was a target date to place this issue on the ballot.

Katheryn Shields said if it is placed on the August 2005 ballot, the deadline to put it on the ballot is May 24, 2005. She said Dan Tarwater, Scott Burnett and Dennis Waits have been working with her on this issue.

Dennis Waits, County Legislator, said he understands there is a meeting scheduled to be held on Thursday, March 3 at 4 p.m. so that the Chiefs can offer some clarification of their position.

Dan Tarwater, Chairman, said they are looking at an entire package which will include the quarter cent sales tax in addition to monies from the State and City. This package will be worked out before taking it to a vote of the people.

Resolution #15398 was adopted at this time. See page 6 for details.

Robert A. Stringfield, County Legislator, introduced Bill Wilcox and John Pennell who have been phone soliciting to get contributions for this cause.

Bill Wilcox said Tina Porter, mother of the missing children, will be on the Dr. Phil show on Wednesday, March 2 regarding the Amber Alert. He also mentioned that there is a benefit to be held at the Rick West Theatre and Convention Center on March 20 at 3 p.m. and 8 p.m. Tickets are \$20.00 per seat and it is to fund TIPS.

Robert Stringfield thanked Ken Evans, Public Information Officer, because he made this happen with his contacts. Mr. Stringfield presented the courtesy resolution to Ed Parker and his employees.

7 FINAL PASSAGE OF PROPOSED ORDINANCES

	Robert A. Stringfield said \$4,000.00 per complaint is how much it cost taxpayers for the ombudsman to handle 31 complaints in 2003, according to a study that cost taxpayers \$16,000.00, which was the Fowler Report. The unpublicized report has gathered dust since it was issued last September. He said he was introducing a resolution to put a stop to waste and abuse of tax dollars. He told how he honestly and sincerely feels about an ombudsman office that today is not worth its weight in salt. The ombudsman is hired and may be fired only by an eight-member volunteer commission appointed by the County Executive, who names the chair. To preserve the independence of the ombudsman, the Charter framers made no provision for removing the commissioners appointed for terms.				
	The buck must stop with the County Executive. She is accountable for the performance of the eight volunteer commissioners. The buck must stop with the Legislature, accountable for the quality of candidates for the commission. The buck must stop with the eight commissioners, accountable for the performance of the ombudsman.				

He said too much money has gone down the drain for too many years in front of our very eyes. Today the ombudsman office is a sham, a phantom that we pay lip service to. We have misled the public with "window dressing." Why \$4,000.00 average for the handling of a single complaint, an exorbitant and preposterous sum? What does an effective ombudsman bring to government? Sunshine. The ombudsman turns the spotlight on us. Maybe that is why the County Executive and the Legislature may want the ombudsman office to fail. Those who don't like the ombudsman, don't like the spotlight. The ombudsman brings transparency to government. Sunshine is what the public deserves, not darkness. Complaints generate change and help us do our jobs better. We learn from complaints. We learn what we are doing bad, so we can then learn how to serve the public better. What should happen? The ombudsmen must be resurrected from the ashes of shame. The ombudsman office must be highly publicized. The ombudsman must be marketed so people know where to complain and enjoy confidence that their complaints will be investigated thoroughly and that they will receive a response quickly.

An effective ombudsman is good for the County Executive, good for the County Legislature and good for the vast majority of dedicated employees of Jackson County. Why is the ombudsman good for Jackson County employees? More often than not, as other government ombudsman offices have proved, the ombudsman supports government employees 80% of the time. If the complaining citizen gets angry because the ombudsman supports an employee, the complainer has the ombudsman to blame more than the accused employee.

An effective ombudsman detects patterns of complaints. Root causes of complaints are unearthed. Action is taken. County employees suffer complaints because we leaders do not flush out the root causes of complaints. When everybody on a team works together with high morale and feeling good about the performance of their fellow players of the team, they win the Super Bowl. Mr. Arbanas has done that, so he knows the feeling.

Mr. Stringfield said to look at the scandals that have reached us recently in Jackson County. From the scandal of the Prosecutor accusing the County Executive of mismanagement of the COMBAT surplus tax, to the scandal of the waiver of interest and penalties on personal property taxes, to the scandal not collecting personal property taxes on airplanes - all this has reflected on us as leaders of Jackson County government. He said he doesn't like it. The scandals have eaten away the confidence citizens have in us. He is not saying that if Jackson County had an effective ombudsman that the scandals would not have occurred. But what he is saying is that when people enjoy confidence in government they are more likely to report fraud, waste and abuse. It is more likely that a scandal will be more quickly exposed and stopped when whistle blowers blow the whistle to an ombudsman they respect. Either we begin to start the process to improve the performance of the ombudsman or the voters will eventually have their say and close down the office. They will amend the charter to abolish the office. If that happens, it will be a national disgrace. Not having an ombudsman inside government serving a population of 650,000 will shame Jackson County, the second county in the nation to give birth to a county ombudsman that opened its doors in 1973.

Why is the ombudsman office so ineffective? He said the public doesn't know it exists. The ombudsman must be publicized and marketed and a staff of peak performers must be ready to receive, investigate and resolve complaints. Complaint forms must be circulated in city halls and courthouses and tax assessment and collection offices throughout the county, even in libraries. The web site of the ombudsman must be improved among many other things. In summary, he said the Resolution has less to do with the ombudsman commission chairman and more to do with the County Executive and the Legislature, all of whom have gummed the issue to death. The time has come to put teeth into a solution. This means getting the right people in place, funding the office adequately and paying volunteer commissioners enough to cover their expenses.

He said the Resolution he is introducing recommends the County go by a letter from Sidney Willens sent per a request from the County Executive dated February 23. He then read the BE IT RESOLVED paragraph of Resolution #15401. He mentioned that Sidney Willens was the first chairman of the OHRCC. He has volunteered to consult, free of charge, to get OHRCC where it needs to be. His first recommendation requests the Chairman of OHRCC to tender resignation followed by invitation to legislators to propose a panel of three names from which a successor can be selected. The second recommendation is a signed commitment of "minimum expectations" from individual commissioners to attend 12 monthly commission meetings yearly in Kansas City or Independence with no more than two excused absences for good cause only and to meet at least once a year in another city or town in Jackson County for the purpose of receiving complaints. The third recommendation is to run an advertisement in selected newspapers as follows: Help Wanted: Jackson County Ombudsman Commissioners. Must be able to regard the performance of Jackson County officials with cool detachment and to cast a critical eye on heavy-handed administrative rules and bureaucratic red tape. Must be willing to listen to complaints regardless of how petty and even if they come from the most chronic complainer. No salary. Submit resume to your Jackson County legislator on or before June 1, 2005. Mr. Tarwater agrees that Mr. Willens attend a legislative meeting to explain how and why an effective ombudsman works to the ultimate benefit of elected and appointed officials.

Henry C. Rizzo asked if it would be a charter change to submit a panel of three people.

Mr. Stringfield said the charter does not address anything where the County Executive or Legislature could do anything about the commissioners once they are in office.

Henry C. Rizzo asked if the Legislature has any control over the Director of OHRCC or its staff.

Mr. Stringfield responded no, the OHRCC Commission has control.

Dennis Waits, County Legislator, said this is not a new topic for the County Legislature, as it has been dealing with this issue for quite some time. He said Jay Haden, Acting County Counselor, recommended that the Legislature retain the National Ombudsman Association who prepared the report. The Legislature felt that was the right approach because we needed someone who was experienced and clearly independent. There is a systemic problem because the OHRCC is an independent entity under the charter, and the Legislature and Executive do not have any control. He believes that we do need changes which is why he introduced a Resolution with suggestions. He agrees the office needs to have higher visibility because they are currently hidden from public access. He said he and Troy Thomas, Chief Financial Officer, have looked for other spaces but have been unsuccessful. He said he would not even oppose moving the office to Independence.

Katheryn Shields said serving on the OHRCC Commission is a thankless job. Most of the female members have either resigned or are going to resign because they are afraid to attend the meetings. There is constant harassment and intimidation.

Dennis Waits said Katheryn Shields has had ongoing dialogue with Mr. Willens to try to figure out how to address this. Many things can be done but they will require charter changes. There are also budget considerations because if all recommendations in the Fowler report are implemented, it will be an efficient office but it may cost between a quarter to half million dollars a year. The inception of the OHRCC was during a time when there was concern about discrimination in hiring practices and treatment of citizens. Over the last four years, there have been some changes in society and changes in federal and state law and Jackson County has an excellent record as far as dealing with these problems without resulting in complaints to the OHRCC. He said he does not think the Fowler report is a waste of money since we are using it as a basis to make changes to the OHRCC.

Katheryn Shields said Mr. Waits made excellent points. The framers of the charter have put an attendance requirement in place which mirrors that of the County Legislature. It states that if a member of the OHRCC Commission misses more than three consecutive meetings without an excuse then they can be terminated. The framers believed in the independence of this function and the charter specifically exempts OHRCC from the executive power to consolidate, abolish, and reorganize departments. Article X, Section VI reads "This office shall not be subject to the power of the Executive set forth in Article IV, Section XI of this charter." She said it is true that there are not a number of complaints that go to OHRCC. That does not mean that the citizens of Jackson County are mute. They are finding other avenues to bring their concerns about County government. County legislators receive calls from their constituents and they very diligently answer the concerns from citizens. The County Executive's office also works with departments to answer any complaints or questions from citizens.

Katheryn Shields said she has been talking and meeting with Mr. Willens regarding this OHRCC issue. She agrees with him on the importance of OHRCC. She does not agree with him that the way to affect change is to attack the citizen members of the board. She thinks Chairman Davis of OHRCC has worked hard and he brings openings to her attention. Mr. Davis has also talked to County legislators about problems they face. She is not willing to be so ungrateful for his work and time, to ask him to resign. She is anxious for Mr. Willens to come and speak to the County Legislature about his suggestions. She welcomes his input as he is a knowledgeable man with a great mind.

Henry C. Rizzo said it is a fair statement to say that the charter framers did this to keep politics out of it.

Katheryn Shields agreed. She said the idea of an ombudsman is that they want it to be independent. The reason you have a commission, is to create that additional measure of independence. The ombudsman and staff are reporting to the commission and not to any specific concerns that the Legislature or Executive may have. They represent the citizens not the elected officials.

Bob Spence, County Legislator, said he has trouble with this resolution, in particular the first recommendation, because there is a tremendous problem getting people to serve on this commission. He said Mr. Willens stated in his letter that the Chairman not once responded to him and Mr. Spence understands that the Chairman has been to Mr. Willens house for a meeting. To attack members of this committee individually will drive more members away from the commission and make staffing more difficult.

Katheryn Shields said she thinks everyone is on the same page in terms of what needs to be accomplished. Everyone wants OHRCC to be an effective representative for the citizens of Jackson County. She thinks they all need to work together to figure out how to accomplish this task.
