REQUEST SUMMARY	<p>An ORDINANCE authorizing the County Executive to transfer funds and to execute agreements with certain outside agencies funded by the County's Anti-Drug Sales Tax Fund for the 2013 fiscal year, which are engaged in anti-violence activities and purposes, at an aggregate cost to the county not to exceed \$540,00.00.</p> <p>Exhibit A indicates the outside agencies and funding levels as recommended by the Jackson County Drug Commission for the 2013 fiscal year.</p>														

	<p>Background: The Anti-Drug Sales Tax fund authorizes the County to execute agreements and contracted service for the purpose of providing substance abuse treatment, prevention, grant match, and other anti-drug and anti-violence initiatives in the community. These recommendations are based upon evaluation of proposals that were submitted in response by community providers to a Request for Proposal (#59-13) for a special COMBAT Anti-Violence Initiative.</p> <p>A change was made in 2009 in the authorizing language for COMBAT to add a violence component to the already effective anti-drug strategies. In addition, a concentrated effort was taken to re-brand COMBAT and to implement an aggressive anti-violence marketing campaign. The recommendations to fund these proposed programs is to continue COMBAT's efforts to assist Jackson County in providing effective strategies to reduce the violence within our community.</p> <p>Scoring was completed by independent reviewers and recommendations were presented to and approved by the Drug Commission on November 19, 2013, with the recommendation that they be presented to the Jackson County Legislature.</p>
