Pursuant to section 1054.6 of the Jackson County Code, the Parks + Rec Department recommends a split award of a Twenty-Four (24) Month Term and Supply Contract with One (1) Twelve Month option to extend for the rental of Heavy Equipment to H&E Equipment Services and Roadbuilders Machinery and Supply Co. under the terms and conditions of Invitation to Bid No. 25-009 as the best qualified bids received.

Parks + Rec utilizes these contracts to rent heavy equipment needed to complete projects throughout the park system like rollers for the installation of asphalt, and lifts to prune trees and set up Christmas in the Park displays.

Both companies provided comprehensive lists of available heavy equipment, which will satisfy our needs throughout the year.

The department's estimated spending is \$26,500.

Road Builders has provided outstanding customer service through other term and supply contracts and is qualified to provide the services needed through contract 25-009. H & E Equipment would be a new vendor for Public Works but a viable option if one is needed.
