WHEREAS, the Family Court Division has been awarded the Family Treatment Court Program Grant by the State of Missouri Treatment Courts Coordinating Commission, for the period of July 1, 2024, to June 30, 2025; and,

WHEREAS, the purpose of the Family Treatment Court Program is to help substance-abusing offenders break the cycle of addiction and avoid the crimes that often accompany addiction; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the undesignated fund balance of the 2024 Grant Fund:
