

**SECOND AMENDMENT
TO
ENGINEERING SERVICES CONTRACT (ESC)**

This Amendment is made part of an agreement dated April 17, 2017, between Jackson County, Missouri, and McClure for Design and Construction Observation Services of project BRO-B048 (55). The purpose of this Amendment is to revise our DBE subcontractor list and their participation by adding one new DBE subcontractor and revising participation for two DBE subcontractors.

The new DBE subcontractor is Mustardseed Cultural & Environmental Services, LLC, who will perform the required Lead and Asbestos Testing for an amount of One Thousand Eight Hundred Ten Dollars and No Cents (\$1,810.00).

The revised amount for services by Shockey Consulting Services, LLC will be Two Thousand Six Hundred Seventy-Five Dollars and No Cents (\$2,675.00).

The revised amount for services by Geosource will be Two Thousand Five Hundred Forty Dollars and No Cents (\$2,540.00).

The attached sheet (Exhibit A) is a revised Article II to replace the original Article II of the ESC. The revisions included in this Amendment will not change the current contract maximum of Ninety-Nine Thousand Eight Hundred Fifty Dollars and No Cents (\$99,850.00) (Design phase is \$95,150.00 and Construction Observation phase is \$4,700.00), without further authorization.

ARTICLE II - DISADVANTAGED BUSINESS ENTERPRISE (DBE) REQUIREMENTS:

- A. **DBE Goal:** The following DBE goal has been established for this Agreement. The dollar value of services and related equipment, supplies, and materials used in furtherance thereof which is credited toward this goal will be based on the amount actually paid to DBE firms. The goal for the percentage of services to be awarded to DBE firms is 10% of the total Agreement dollar value.
- B. **DBE Participation Obtained by Engineer:** The Engineer has obtained DBE participation, and agrees to use DBE firms to complete, 13.67% of the total services to be performed under this Agreement, by dollar value.
