WHEREAS, by Resolution 17684, dated September 26, 2011, the Legislature did award a contract for Legal Files Case and Matter Management System services for use by the Office of County Counselor to Legal Files Software, of Springfield, Illinois, as a sole source purchase, at a cost to the County not to exceed \$67,914.00; and,

WHEREAS, by Resolution 17874, dated April 2, 2012, the Legislature did authorize the purchase of two additional licenses and related services because the Office of the County Counselor increased its staff; and,

WHEREAS, the Office of the County Counselor is adding an additional attorney position soon and an additional Legal Files user licenses and related services will be needed, at an additional cost to the County not to exceed \$2,856.00; and,

WHEREAS, a transfer is necessary to place the necessary funds in the appropriate spending account; and,

WHEREAS, the County Executive recommends said transfer; now therefore,
