SUMMARY: The Drug Task Force is requesting the purchase of two vehicles for use by the Task Force for a total cost of \$99,502 from Task Force Federal Forfeiture fund 047-4151-58120.

Corwin Motors of Springfield, Missouri, State of Missouri Contract No. MC250182 Series (MC250182004) responded to the Motor Vehicle Price Quote Request form (PQF) issued by the Drug Task Force with an "off the lot" quoted total price of \$43,939 for a 2026 Jeep Wrangler Sport VIN 1C4PJXDG1TW218543.

Corwin Motors of Springfield, Missouri, State of Missouri Contract No. CC24166201-005 responded to the Motor Vehicle Price Quote Request form (PQF) issued by the Drug Task Force with an “off the lot” quoted total price of \$55,563 for a 2024 Jeep Wagoneer VIN 1C4SJVPORS140113.

Total cost for the two vehicles is \$99,502.

Pursuant to Section 1030.4 of the Jackson County Code, the Drug Task Force recommends the purchase of the 2026 Jeep Wrangler Sport for \$43,939 and the 2024 Jeep Wagoneer for \$55,563 from Corwin Motors of Springfield LLC, Springfield, MO, under the terms and conditions of State of Missouri Contract No. Contract No. MC250182 Series and CC24166201-005 and existing competitively bid government contract. As noted above, Corwin Motors provided the Price Quote Request Form as required by the contact.
