12 COUNTY EXECUTIVE ORDERS

97-17

In accordance with Jackson County Code Section 706.1, I hereby promulgate the following Personnel Rule, being a new definition under Rule 2 of "probationary employee:"

Probationary Employee. An employee during the first six months of County employment in a merit position, except Sheriff's deputies, whose probation lasts one year following the completion of training, and park rangers, whose probation lasts six months following the completion of training.

To the extent that Executive Orders or the Personnel Rules previously promulgated are inconsistent herewith, the inconsistent provisions are hereby rescinded.

This Executive Order shall be effective immediately.

Victor E. Callahan, Chairman, asked for an explanation of this Executive Order.

Sandra Schermerhorn explained that the Personnel Department needed this in order to keep the Personnel Rules consistent with the Jackson County Code.

Victor E. Callahan asked for an update on the Personnel Rules for the Legislature.
