

**FIRST ADDENDUM TO AGREEMENT
2010-2011 Emergency Shelter Grant Program**

THIS FIRST ADDENDUM TO AGREEMENT is entered into this 3 day of May, 2011, by and between **JACKSON COUNTY, MISSOURI**, a Constitutional Home Rule Charter County, hereinafter referred to as the County and **HILLCREST MINISTRIES**, 401 North Spring, Independence, MO 64051, a Missouri not-for-profit corporation, hereinafter referred to as **Contractor**.

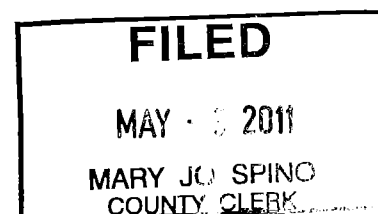
WHEREAS, by Ordinance 4244, dated September 20, 2010, the County and Contractor did enter into an agreement whereby Contractor agreed to provide homeless assistance pursuant to the State of Missouri 2010 Emergency Shelter Grant (ESG) Program, at a cost to the County of \$6,917.00; and,

WHEREAS, because another ESG agency has relinquished its allocation of \$4,667.00 in grant funds, the State of Missouri has authorized the re-allocation of those funds to Contractor, increasing its allocation to \$11,584.00

WHEREAS, by Resolution 17583, dated April 25, 2011, the County Legislature has authorized the County Executive to enter into this Addendum to the Agreement with Contractor;

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and Contractor respectively agree as follows:

1. Except as herein specifically modified or amended, all of the terms and conditions of the Agreement between the parties authorized by Ordinance 4244, dated March 30, 2011, shall remain in full force and effect and the terms and conditions thereof are incorporated herein by reference.



2. The total sum to be paid to Contractor is hereby increased by \$4,667.00, in a total amount not to exceed \$11,584.00.


3. This Addendum shall be effective March 31, 2011, and shall extend until May 13, 2011.

4. This Addendum, together with the Agreement authorized by Ordinance 4244, dated March 30, 2011, incorporates the entire agreement and understanding of the parties.




