A RESOLUTION approving the settlement of the claim of Servpro of Lee's Summit, MO, for a total payment by the County of \$103,164.53.

RESOLUTION NO. 21207, March 20, 2023

INTRODUCED BY DaRon McGee, County Legislator

WHEREAS, Servpro of Lee's Summit, MO, has made a claim against the County for costs incurred for services and materials in responding to and remediating water damage to the downtown courthouse that occurred in August 2022; and,

WHEREAS, after a thorough investigation, the County Counselor recommends a settlement in the amount of \$103,164.53, to be paid by the County to Servpro of Lee's Summit; and,

WHEREAS, the proposed settlement will limit the County's financial obligation in this matter and is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to settle the claim by the total payment of \$103,164.53, in full, final, and complete release of all of its claims against the County and all of its employees, officers, agents, and servants, as to any damages incurred; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to issue a check in the amount totaling \$103,164.53 in full and complete settlement of this claim, payable to Servpro of Lee's Summit, MO.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
